The United States Probation and Pretrial Services Office for the District of Montana is seeking to purchase 15,000 units of Non-Instrumented Drug Testing (NIDT) Devices. While the mandatory drugs are our baseline requirement, we are open to consideration of devices that include additional panels. We are accepting OPEN MARKET quotations until **5:00 p.m. Mountain Time, Monday, January 5, 2026**, for the following services/supplies:

Description: Non Instrumented Drug Testing Devices.

1. The NIDT devices **must** include the following drugs and confirm positive at the cut-off levels set forth below.

Cannabinoids	50 ng/ml
Benzoylecgonine (Cocaine)	150 ng/ml
Buprenorphine	10 ng/ml
Amphetamine	500 ng/ml
Methamphetamine	500 ng/ml
Opiates (Morphine, Codeine, Hydromorphone, Hydrocodone)	300 ng/ml
Oxycodone	100 ng/ml
Ethyl Glucuronide (ETG)	500 ng/ml
Fentanyl	10-20 ng/ml

2. In addition to the aforementioned drugs and cut-off levels, the District of Montana will also consider NIDT devices that include any combination of the following drugs with preferred cut-off levels:

Tramadol	200 ng/ml
Benzodiazepines	300 ng/ml
MDMA	500 ng/ml
Methadone	300 ng/ml
6-AM	10 ng/ml
K2	20 ng/ml
PCP	25 ng/ml
Kratom	300 ng/ml
Ketamine	300 ng/ml

3. The vendor selected will be based on the following criteria:
- a. The lowest priced, technically acceptable offer.
4. The vendor will confirm:
- a. They can deliver the devices to the District of Montana within 14 days of award.
 - b. The price quoted includes shipping/delivery.
 - c. They are able to ship the devices to the five USPO locations in Montana (Missoula, Helena, Billings, Great Falls, and Glasgow).
 - d. The NIDTs have integrated temperature strips and adulteration panels.
5. U.S. Probation & Pretrial Services is unable to pay for products/supplies in advance. The vendor will submit invoices after the supplies have been delivered.
